Respected Sir,

We are in receipt of a complaint from our secretary offshore in BHS platform Mr Ravi Wate that the deep freezer is not working for over four weeks, please find copy attached for your perusal.

We accept the fact that age and volume combined together makes things critical as far as maintenance of machinery and gadgets are concerned, and MH- Asset is no exception to this fact. Without exaggeration, being in the hands of able and experienced administrators everything comes under the umbrella of, "Not Impossible".

The above prevailing circumstances of deep freezer remaining in non-operational condition for over four weeks, when more than 250 regular and contractual employees are on board are a matter of serious concern. We understand OIMs are either helpless or we do not have the updated information of the action initiated at his end, but physically it is yet to be attended.

The issue has been discussed with the OIM on board for more than one occasion, failing to receive a convincing reply our secretary has rightly applied his mind without resorting to aggression, requesting us to raise the level by bringing it to your authority and Surface Managers notice.

We look forward and remain convinced, that your esteemed authority gauging the seriousness will have a personal overview and speed up the need in making the deep freezer operational deploying the right agency, and not handing over to the agencies who are incompetent and pedestrian in nature, where we only landing in loosing ONGCs money at the cost of causing inconvenience to our employees.
