Subject: Reimbursement of 'Diet Charges' charged by hospitals for COVID-19 positive patients of ONGC during hospitalization.

Respected Sir,

It has been reported by our employees found COVID-19 positive and were admitted in the hospital for treatment that Rs. 3,000/- to Rs. 6,000/- has been recovered from their salaries as 'Diet Charges' by ONGC. Some of the employees have been paid these charges in cash when they were discharged from the hospital.

It is pertinent to mention here that most of the employees were admitted from Rig S/Kiran and S/ Jyoti found COVID-19 positive. From their salaries also same amount has been recovered as **'Diet Charges'**. The recovered amount is also suspected as in some cases Bisleri bottles supply, which is shown 6 to 8 bottles per day in the bills, for 6 to 7 days stay in the hospital. The amount recovered as **'Diet Charges'** is unjustified. Moreover, the same amount has been recovered from the employees admitted in Reliance Hospital in Andheri and Kharghar, Nanavati Hospital. More complaints have been received of Raheja Hospital, Mumbai, only.

Your esteemed authority is requested to stop such recoveries from the salaries of employees found COVID-19 positive and admitted in the hospitals. At the same time all **Diet** bills should be checked thoroughly as amounts recovered are unjustified and very high.
