Respected Sir,

In line with our existing policies ONGC employees including executives and non-executives performing On/Off duty in offshore have to do **PME (Periodical Medical Examination)** every two years along with their spouse.

Presently employees doing On/Off duty from their native place/residence are coming to Mumbai to do the PME. Your esteemed authority is aware that accommodation in our Guest House at Santacruz has been discontinued for stay since 2019 and are giving Hotel accommodation to our employees performing duty in Offshore and doing On/Off from their native place, neither Hotel accommodation for PME is permitted.

Last five years we have impanelled Hospitals in cities like Nagpur, Aurangabad, Pune & Nasik as many of our employees have been recruited from entire Maharashtra State. Presently these employees are facilitated for medical assistance for themselves, their families and dependent parents in these hospitals.

Presently employees coming to Mumbai for PME along with their Spouse are being provided accommodation in ONGC Poonam Nagar transit accommodation. As the rooms available in the Poonam Nagar are very limited, we are not in a position to provide them accommodation. So as to overcome this problem, we need to include PME facility in our empaneled Hospitals in cities of **Nagpur, Nasik, Aurangabad & Pune** with Credit facility. It will save time of our employees, travelling expenses and their off period also. So also, employees staying around these cities can also avail the facility of PME in these hospitals.

Your esteemed authority is requested to kindly give direction to the concerned authority for including facility of PME with credit note to save the time, money and the off period of employees performing duty in offshore.




