We are in receipt of a letter from crew members posted on NQO Platform regarding non supply of **PPE items as well as Towels, Hand Cleaning Soap** etc. Please find attached the copy of the letter for your perusal. Non availability of Dungarees, Hand Gloves is a matter of serious concern. The last Dungarees and towels received on the platform was in the **year 2013**. It has been almost two and half years since dungarees are not procured. Your authority must be aware that Socks, Hand Gloves, Hand cleaning soap is required for daily tasks.

The non-availability of these items impacting the **comfort and safety** of the crew members including Executives. It is surprising to note that even after repeated requests no response has been given to resolve the issue, leaving the crew members in a more difficult working environment.

Your esteemed authority is requested to kindly look into the matter and directions given to the concerned authorities to initiate the action for procurement of above mentioned items at the earliest as there is widespread unrest among the crew members on the platform.

Despite repeated requests to the management, there has been no adequate response or resolution to this matter, leaving us in a difficult working environment.

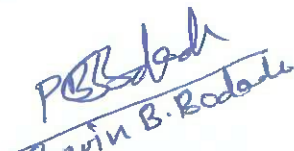
As representatives of **Karmachari Sanghatana NQO Platform**, we request the union's intervention in this issue. We urge you to communicate with the management on our behalf.

We trust that the union will take the necessary steps to resolve this issue in the best interest of all KS members.

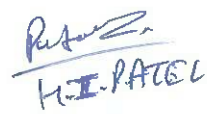
