Subject: Request for Issuance of "Stop Work Form" Policy at ONGC Mumbai Installations.

Respected Sir,

We are requesting for the implementation and issuance of a "Stop Work Form" policy for ONGC Mumbai, similar to the one already enforced by ONGC, Rajahmundry Asset vide Office Order No. ONG/RA/ST/Safety/2022-23/July/1 dated 05.07.2022.

As per the aforementioned policy, it has been recognized that every individual working at production installations irrespective of their rank, designation or departmental affiliation, including contract personnel should be empowered with the authority to stop work without fear of reprisal, if certain safety concerns arise. The core intent of this policy is to foster a robust safety culture and proactively mitigate risks that could potentially endanger personnel, assets or the environment.

The "Stop Work Form" may be issued under the following conditions:

- When unsafe conditions or behaviours exist that pose imminent danger to individuals, equipment, or the environment.
- When work deviates from the pre-agreed program.
- When personnel are unable to fully comprehend the safe operating procedures.

Upon issuing the "Stop Work Form," the concerned individual must promptly notify the immediate supervisor or shift in-charge of the installation. All such incidents should be recorded in a dedicated "Stop Work Form Register." Resumption of work must only proceed once all identified hazards or unsafe behaviours have been satisfactorily addressed and appropriate safety measures have been implemented.

In view of the critical importance of safety and risk prevention, We kindly request that **ONGC,Mumbai** consider adopting a similar procedure and issue an official order to authorize the "**Stop Work Form**" across its installations.

We believe that such a policy will not only align ONGC Mumbai with best safety practices but also reinforce ONGC's ongoing commitment to ensuring the highest standards of workplace safety.

### Stop Work Form

Every person working in the Production Installations, regardless of seniority, position, or department, (including contract crew) has the right to "Stop Work" without the fear of reprisal.

"Stop work Form" can be issued under the following conditions

- If Conditions or behaviors exist that are unsafe and poses imminent danger to person(s), equipment or the environment
- If the work deviates from the pre agreed programme
- If the person is unable to apprehend the safe operating procedure

The person after issuing the "Stop work Form", shall immediately notify the immediate supervisor or Shift In-charge of the Installation and the "stop work Form" details have to be entered in a "stop work Form register"

Work that was discontinued due to a "Stop work Form" shall not be resumed unless all safety measures had been taken to resolve the unsafe conditions or behaviours.
