Subject: Request for Immediate Completion of Hospital Empanelment to Avoid Employee Hardship.

Respected Sir,

With reference to your **Circular No. WOU/RO/GM-MS/Letters/25-26/50, Dated 19.09.2025** regarding **extension of empanelment of all the panel hospitals till 31.12.2025**, we wish to place our concern on record.

While we understand the unavoidable circumstances that have led to the delay in the empanelment process, we would like to bring to your notice **the serious hardship faced by employees and their dependents due to non-availability of timely empanelment of hospitals**. Medical treatment is an essential and unavoidable need and any delay in hospital empanelment directly affects the well-being, safety and financial security of our members.

If hospitals remain de-empanelled beyond the stipulated period, employees may be forced to seek treatment at non-panel hospitals, which will result in delayed access to urgent medical care, increased out-of-pocket expenditure, and administrative difficulties in claiming reimbursement.

All the hospitals have served ONGC beneficiaries for years. Their absence has led to increased travel, financial burden, limited access to specialist care, and reduced emergency response capability especially in **Uran**, where **Palvi Hospital** was the nearest referral centre for plant-related injuries. **It's no need to elaborate that on 8th September 2025, No casualties or injuries were reported in the fire that broke out due to a ruptured "Gas Pipeline" in the "Terminal area" of the Uran plant.** Similarly, residents in Navi Mumbai (Vashi, Nerul, Belapur, Ulwe, Kharghar, Panvel) and Kalyan-Dombivli areas are now left with very limited empanelled hospital options.

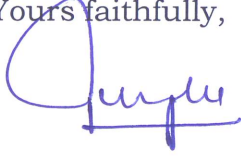
In the larger interest of the employees and their families, **we strongly urge the Management to ensure that the empanelment process of all the hospitals is completed well before contract end date of Hospitals**, or to put in place an interim arrangement that guarantees uninterrupted medical facilities for all employees and dependents.
