Vasudhra Bhavan & 11-High w.e.f. 1.12.2007.

Respected Sir,

This is in reference to the irregularities in catering services by Star Shipshore Caterer, in rig Sagar Kiran, which is presently in Kochi for dry-docking.

- Not following menu as per accepted tender conditions.
- Not providing toiletry kit & soap to rig staff and officers.

We along with Tool Pusher, Rig Manager as well as concerned DGM (D), Mr. Chakraborty have been perusing to resolve the issue for over two months. On 5th Novemebr, in meeting with our General Secretary, Mr. Pradeep Mayekar - Rig Manager had assured in two weeks the issue will be resolved, as nothing resulted till today i.e. 26.11.2007 as per notice, the staff of rig Sagar Kiran proceeded on hunger strike.

Today in discussion with the undersigned along with, DGM (D) and Rig Manager and a telephonic discussion with Mr. Rangarajan, CM (CMC) it was assured the matter will be resolved in 4 days, accordingly we have postponed our hunger strike.


We bring to your notice, in compliance to the assurance by Mr. Rangarajan, CM (CMC) if nothing materializes till 30th November, 2007, we will be left with the only option of "Resorting to indefinite hunger Strike" on all offshore installation and all office complex w.e.f. 1.12.2007, 0600 hrs. onwards with the demand of black listing the said caterer for non compliance of agreed tender conditions.

Your esteemed authority is requested to interfere in the matter to have an amicable solution.
