Subject: Acceptance of Part time & correspondence Diploma from recognized institutes as qualifying criteria for departmental candidates.

Respected Sir,

This is in reference to the ongoing recruitment in WOU at A2 level with Diploma qualification and to our letter dated 30/09/2009 on the above subject.

Considering part- time & correspondence diploma from recognized institutes as qualifying criteria for recruitment was discussed in the last JCM held at New Delhi on 12 & 13 Oct. 2009 and was accepted in the case of departmental candidates. The delay in circulating the minutes of meeting prevented the local R&P department in making the necessary changes in accepting the applications. Circulation of MOM was again brought to the notice during wage negotiation meeting and was confirmed to be issued shortly.

It is once again requested that either the minutes be issued or directives be given on the above issue at the earliest, as non acceptance of these applications will deprive the departmental candidates from the said opportunity available in hand. We are submitting hard copies of candidates with part time diploma as these applications are not registered ON-LINE.

Moreover valuing the understandings of bilateral meetings with recognized unions will go a long way in having well balanced Industrial Relations. Under the circumstances we may have to delay the recruiting process at A2 level.
