Subject: Inclusion of additional qualification.

Respected Sir,

It has been reported that the diploma/degree acquired by employees with due permission from ONGC after 2007 with new syllabus through Institute of Mechanical Engineers (India), Mumbai have applied for inclusion of additional qualification is being kept pending in want of clarification from management.

It is necessary to mention here the office order issued by ONGC guides the inclusion of qualification acquired through IME (I), Mumbai. The Details of office order are as under.

The ONGC office orders file no 7(2)/99-RP-P dated 6^{th} October, 2008 which states.

- 1. Degree/Diploma courses offered by IME (I) up-to 10.06.2002 are recognized.
- 2. Qualification of individuals registered prior to 10.06.2002 and course completed up-to December, 2006, with old syllabus are recognized.
- 3. For Degree / Diploma awarded after 16.10.2006 courses offered with new syllabus are recognised and
- 4. Degree/Diploma awarded after 17.04.2007 would require mandatory approval of Distance Education Council.

Sir, the above mentioned office order's point No 3 & 4 contradicts each other, which approves same course up to 2006 and not approve after 2007. Moreover, the Institute of Mechanical Engineers (India), Mumbai is conducting Technician Engineers and Associate Membership courses (Equivalent to Diploma and Degree in Engineering) which are recognised by Ministry of HRD, Govt of India and Syllabus of these courses are approved by AICTE. These courses do not fall in the preview of Distance Education Council.

Therefore it is requested to make necessary correction in above referred office order so that cases pending after 2007 may be regularised.
