Sub: 1/3rd OT restrictions not applicable to relieving shift pattern duty in operational area.

Respected Sir,

It is observed that over a period of one year in Uran Plant key operational areas are exposed unmanned due to restriction imposed towards overtime, i.e. including operational areas like LPG-I, II, Air Compressor etc. The above circumstances have encouraged certain employees to conceive the perception that it is not serious to leave plants un-manned. In general, practicing unsafe working condition has become permissible parameter.

We are all witness to accidents in ONGC (Onshore – Offshore) and its repercussion. Uran Plant is no exception. Let us live to the standards we have set in achieving ISO rating, and not create unsafe working condition by leaving vital operational areas un-manned.

Further, in reference to office order (12/2006) dated February 13, 2006, which is an extension of office order No. 18 (3)/97-OTA/EP Dated 12.08.1998, the said office order confirms "Where operations are of continuous in nature, restriction of 1/3rd OT of monthly Basic + DA can be relaxed." The manpower chart of all the four shifts, mainly in the field area is self explanatory, that redeployment of all class III employees in place of class II & I officers will be apt solution in reducing O/T in the plant. Till such time redeployment is not available in hand, it is requested that O/T restriction may please be relaxed for field shift personnel.

We are enclosing the circulars of competent authority for your perusal, when efforts towards minimizing OT is appreciated it is not at the cost of Plant & Human Recourses safety. Your esteemed authority is requested to look into the matter and do the needful at the earliest. So that unsafe work conditions are erased maintaining amicable work atmosphere.
