More over why so much of permutation combination on recruitment of workmen, when the organization is recruiting as many as 150 to 200 GT's every year i.e. AEE's where induction gross salary in offshore installation, amounts to Rs. 36,000/- plus.

When we don't question the recruitment of AEE's on regular basis, as we understand that they are need based, we request your esteemed authority to regularize all the existing fixed tenure/term based employees from their date of employment in ONGC in negotiation with the undersigned.

It is pertinent to mention that these entire Tenure/Term base employees are deployed in our organizations core activity i.e. Drilling in offshore, hence secondary treatment is highly uncalled for.

We also accept the fact that the process of regularization will take some time. Till such time, in line with the notification dated 10.12.2003, annexed to the Industrial employment (standing orders) Act. 1946. i.e. when their tenure is fixed, their wages, allowance and other benefits be at par with regular/permanent employees, these be implemented w.e.f. their date of joining ONGC.
